WHO IT IS FOR?

ELIGIBLE AUSTRALIAN STUDENTS OR YOUNG AUSTRALIAN GRADUATES WHO WANT TO WORK & HOLIDAY IN SG

NATIONALITY & AGE CRITERIA?

YOU NEED TO BE AN AUSTRALIAN & TO BE AGED 18 TO 30 AT THE TIME OF APPLICATION

IS THERE ANY CAPACITY / QUOTA FOR APPLICATION?

YES, A CAPACITY OF 500 PLACES AT ANY ONE TIME

WHO CAN APPLY?

CANDIDATE OR APPOINTED EMPLOYMENT AGENCY

WHAT IS THE VALIDITY OF WHVP?

12 MONTHS

IS WORK HOLIDAY PASS (WHVP) RENEWABLE?

NO. THE WHVP IS ISSUED ONLY ONCE.



ANY LIMITATION ON EMPLOYMENT?

YES. WHVP HOLDER CANNOT DO FREELANCE & WORK WITH THE SAME EMPLOYER FOR > 6 MONTHS.

ANY OTHER LIMITATIONS?

CANNOT STUDY OR TRAIN FOR MORE THAN 4 MONTHS INCLUDING INTERNSHIPS
